A public meeting : Keith Moran TIF advisor explained the development of the New TIF II district, and how the district will affect the property owners in the surrounding area.

6:30 P.M. Mayor Phillips called the meeting to order the pledge to the flag was recited.  
All six trustees answered the roll call.

Trustee Shaw made a motion to accept the minutes of the October 16, 2014 meeting as presented to the board. Trustee Barrett second the motion, all six trustees voted yea motion carried.

Trustee Shaw made a motion to accept budget report and pay out standing bills plus:

\*Hose tester was originally approved for \$2,454.95 and price came in at \$4,170.24-additional \$1,715.29 was for attachments and other items necessary for tester.

\*Approved purchasing salt for \$7.3,000-Ribbe will deliver \$70,000 MFT \$3,000 General Fund

\*Insurance renewal came in from Arthur J. Gallagher for Worker's Comp and Liability-Last year it was \$92,621.00 and this year it was \$93,486.00. Our property values increased by 30% this year and we had less than a 1% increase

\*Christmas bonuses-\$200.00 for full time and \$100.00 for part time-see attached list

Trustee Barrett second the motion, all six trustees voted yea motion carried.

Trustee Sheets made a motion to accept the resolution for maintenance of streets and highways by municipality highway code. Revision of MFT expenditures of \$134,726.04 from January 1, 2014 to December 31, 2014. Trustee Shaw second the motion, all six trustees voted yea motion carried.

Joe Glisner gave a presentation on FEIMA flood insurance program. He will research the program, for Grant to proceed with the qualification to the program.

Trustee Sheets made a motion to accept the Resolution for Improvement be Municipal Under the Illinois Highway Code \$250,000.00 (PE I & PE II for "G" street rehabilitation and extension; realignment of 1<sup>st</sup> Street to new intersection with "G" street.

Improvements include earth excavation, pavement removal, storm sewers, pcc sidewalk, pcc pavement, curb & gutter, HMA resurfacing, pavement markings and miscellaneous items of construction. Trustee Shaw second the motion, all six trustees voted yea motion carried.

Trustee Sheets made a motion to accept - Amendment to extend Job P-95-348-10 to revise ending date of obligation AL11180 to extend to September 9, 2016 Trustee Finley second the motion, all six trustees voted yea motion carried.

Trustee Sheets made a motion to allow Keith Moran to present George Shapland - New Chevrolet a TIF (recommendation reimburse Vermilion Chevrolet Buick GMC 50% of the increment for not to exceed 10 years or a dollar value maximum of \$500,000. Trustee Finley second the motion, all six trustees voted yea motion carried.

Trustee Shaw made a motion to allow Keith Moran to present Dave Briggerstaff a one time offer of \$3,000.00 payable upon completion of the project for the installation and connection of water and sewer service, at 3 Lane Street to start a Hydro Graphics business. Trustee Barrett second the motion, all six trustees voted yea motion carried.

Trustee Sheets made a motion re-zone lot 104 and 106 on Illiana Drive from C2 - Highway Commercial to R3 - Multi-Family Residential. Leaving lot 103 as C2 as this lot will be developed for Commercial use. Trustee Shaw second the motion, all six trustees voted yea motion carried.

Grant came in for bullet proof vests that Tif sent in . We received \$2,739.00

Trustee Shaw made a motion to have the Lion's Club House (612 14<sup>th</sup> Street) appraisal to be sold. Trustee Sheets second the motion, all six trustees voted yea motion carried.
