

ORDINANCE NUMBER 2013-06-20

THE APPROPRIATION ORDINANCE FOR THE FISCAL YEAR ENDING ON THE 30TH DAY OF APRIL, 2014 OF THE VILLAGE OF TILTON, VERMILION COUNTY, ILLINOIS.

Be it ordained by the President and the Board of Trustees of the Village of Tilton, Vermilion County, Illinois, that the following appropriation ordinance by the same hereby is adopted as follows:

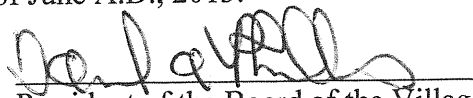

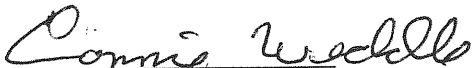
