Trustee Sheets made a Motion to pay listed Christmas bonus' to the Village of Tilton employees. Trustee Smith second. All five Trustees present voted yea. Motion carried.

Trustee Finley made a motion to purchase new LED lighting fixtures at Public Works Building for approximately \$2500.00, decreasing the amount of fixtures from 28 to 14. Trustee Washkowiak second. All five Trustees present voted yea. Motion carried.

Trustee Sheets made a motion to purchase new panels for messaging traffic sign boards, not to exceed \$3,500.00. Trustee Washkowiak second. All five Trustees present voted yea. Motion carried.

Trustee Smith made a motion to accept the new insurance quote from RMA of \$79,437.14, which includes a pay early discount. Trustee Finley second. All five Trustees present voted yea. Motion carried.

Trustee Sheets made a motion for a 6 Ton Weight Limit on First Street between 14th St and Ramp Road (Round about). Trustee Washkowiak second. All five Trustees present voted yea. Motion carried.

Trustee Sheets made a motion to make W 15th St, from Lane to King, one way Westbound. Trustee Barrett second. All five Trustees present voted yea. Motion carried.

Trustee Sheets made a motion to place a 4-way stop at 14th St and 1st St, Trustee Washkowiak second. All five Trustees present voted yea. Motion carried.
